- 2. A Region 6 general membership zoom meeting has been scheduled for Tuesday June 29th beginning at 8:00 pm since we were unable to have our meeting at the PonyXpress ride. As a part of our meeting, we will discuss the 2022 rule change proposals. If you are unable to attend, we would still encourage and appreciate your input on these proposals. The rule change proposals can be viewed on our NATRC webpage. Go to natrc.org and from the homepage move your curser over the Resources tab and then when the dropdown menu appears select Rule Changes/Proposals under Rules. Please share your input with either Marla or me so we know your thoughts on any or all of these proposals. These rule proposals will be voted on at the July national board of directors meeting. A link to this zoom meeting will be sent in a separate email.
- 3. The National Park Service (NPS) is seeking public input to guide the development of a Roads and Trails Management Plan at Ozark National Scenic Riverways. I highly encourage our NATRC family to provide feedback to the NPS so that we do not lose access to these horse trails. At issue are the equine trails in the upper Current River area that are not "designated trails" by the NPS or the Ozark National Scenic Riverways (ONSR). Region 6 has held NATRC rides in this area and have used these trails in the past.

If the equine community does not speak up and provide the necessary feedback, we risk these trails being removed and restored to natural conditions. This would affect future NATRC rides in this area as well as local horseback riding facilities that utilize these trails such as Whispering Pines, Pinecrest, Flying W, and Big Creek. Feedback will be accepted until July 18, 2021.

The draft plan includes detailed maps and three options. As trail riders, we want option C to keep trails in the upper Current River. The Back Country Horseman of Missouri and the Trail Riders in Missouri are supporting Option C.
