<u>Directions:</u> From Kansas City: 1-35 South to US 169 South in Olathe. 169 South to Hillsdale exit. Go West 3.5 miles on W 255th Street to Harmony Road, turn right onto Harmony Road, then left onto W 253rd Street to Saddle Ridge Campground. From the South: North on US 169 to the Hillsdale exit. West 3.5 miles on W 255th Street to Harmony Road, turn right onto Harmony Road, then left onto W 253rd Street to Saddle Ridge Campground. From the West: K-68 East from Ottawa to Hillsdale Lake sign (Osawatomie Road) turn North, going over dam. Turn left on Harmony Road just past the Park and Corps Headquarters, then left onto W 253rd Street to Saddle Ridge Campground. Watch for signs starting at Harmony Road.

<u>Trails:</u> Mostly wooded with some open meadows and some rocky creeks and hills. Shoes are recommended, but not required.

<u>Camping:</u> Sites with water and electric are available, as well as primitive camping. Contact the park office at (913) 594-3600, Monday through Friday 8:00 to 4:00 to reserve campsites and tell them you are with NATRC. Water and electric sites are \$23 per night & primitive are \$10 per night both with a one-time \$2.75 fee for the first night. Showers, toilets, and a wash rack are located in camp. Park will collect fees for all vehicles.

<u>Dogs:</u> Must be leashed at all times and are not allowed at management areas, check-in, briefing, meals, etc.

<u>Stabling:</u> A limited number of corrals are available on a first come, first serve basis for safety riders and LeD competitors staying overnight. Type A, B1, & B2 O/N/CP competitors must stationary tied, HiTie (or equivalent), use hitching posts, or sliding tether. No permanent corrals may be used for competing horses while in competition *unless management determines that there are enough for everyone*. Dispose of manure in manure bunkers. Water hydrants and wash rack are available.

<u>Meals:</u> Provided for ride management and judging staff. We'll have potluck dinners on Friday and Saturday evenings for everyone.

<u>Health:</u> Proof of negative Coggins test, and a Certificate of Veterinary Inspection dated within 30 days required for all out-of-state equine.

- A Ride and B1 for O/N/CP: Rider check in begins at 1:00pm on Friday. Horse and rider check in with judges begins at 2:00 pm Friday and continues as needed.
- B2 O/N/CP will check in with ride secretary Saturday afternoon.
- Leisure Division riders check in with ride secretary Saturday and Sunday at 7:30 a.m., followed by check-in of horses at 8:00 a.m., ride briefing at 8:45, and ride out at approximately 9:30.
- Riders requiring late check-in must make arrangements with management.
